This Week, That Thought

A few weeks ago, a video circulated of Rav Hershel Schachter shlita, expressing regret after discovering that his name was added to a clemency request for Mr. Weberman, a convicted child abuser, under false pretenses. Upon learning the truth, he immediately contacted the lawyer the next day to have his name removed, affirming that the abuser should serve his full sentence. In his video statement, Rav Schachter asked that his name be withdrawn, apologized to those hurt by the incident, and clarified that there is no concern of mesirah when an abuser poses a danger to society and the legal system has its own structure of justice.

While this brief column cannot fully address the complexities of reporting, it does highlight several core principles necessary to build a community of safety and integrity:

- Abuse can exists in every community. Leadership must send an unmistakable message that protecting children is nonnegotiable.
- When the fear of Chilul Hashem suppresses reporting, we create space for abusers to operate.
- Real change requires real consequences. Only authorities with legal power can stop abusers.

Our children deserve nothing less than vigilance, courage, and a willingness to confront harm even when it is uncomfortable.



Between the Lines

There is a well-known dispute among the Rishonim regarding the prohibition of mesirah, handing over even a guilty Jew to secular authorities. The Meiri maintains that mesirah is inherently disgraceful and constitutes a Chilul Hashem, as we are meant to submit only to Torah law. By contrast, the Rashba and others view the prohibition as practical rather than absolute: secular courts may impose unjust punishments or lack legal safeguards, leaving the accused vulnerable to arbitrary treatment.

This distinction generates significant halachic implications. For example: May one report a moser to the authorities? What about turning someone in under a legal system that is structured, fair, and predictable? According to the Meiri, the act remains prohibited regardless as it is still a Chilul Hashem. The Rashba, however, would seemingly permit it where justice can be expected.

Pray for the welfare of the government, for without its authority, society would descend into chaos and each person would consume the other alive.

The Ramban in this week's parsha asks: how could an entire city be punished for the crimes of a few? The Rambam answers that the people of Shechem failed to establish courts to enforce the other six Noachide laws. The Ramban, however, argues that the obligation is broader and is to create a just and moral system of governance. It could be that it is this type of law system that would allow one to report an accuser to such a government. The Rama has two opinions within this Ramban if this law system must resemble Torah law or whether it suffices that it be fair, ethical, and well-ordered on its own terms.

Pages of the Past

This Tuesday, the 19th of Kislev, is a celebrated date in Chabad Chassidus. It marks the yahrtzeit of the Maggid of Mezritch, foremost disciple of the Baal Shem Tov, and the day the Alter Rebbe, the first Lubavitcher Rebbe, was miraculously released from imprisonment. At that time, tensions between Misnagdim and Chassidim ran high, and tragically, one of the methods employed in their conflict was reporting opposing leaders to secular authorities and allowing the government to intervene. The Alter Rebbe's arrest was heralded by Misnagdim as a triumph, while his liberation was viewed by Chassidim as a vindication of their path.

Sadly, such tactics are not unique to that era. In an earlier controversy, opponents of the Rambam informed Christian authorities that his writings contained ideas contrary to Church doctrine, ultimately leading to the public burning of his sefarim.
